Where Do we Stand with the Legislature? – 13th Check

We know our members are anxious Many of you are asking, "What about to hear what is happening in the a COLA?" We met in the winter with Legislature regarding the 13th check. Many of you answered our request to email your representative in February, and the bill, HB 1227, passed in the Labor and Pensions Committee 11-0. On third reading in the House, the bill passed 92-1.

At that point, the real battle comes to the Senate. Our lobbyist, Steve Beebe, has been talking, emailing, and phoning senators to ensure that they become aware of our bill. He has put together a short page of talking points that you will see in this newsletter. We are also asking each of you to email your senator, asking them to support the 13th check. We will be contacting members over five different weeks so that as you receive the email asking for help, senators will be hearing from our members over and over through the rest of the session. Please follow the request of the email when you receive it.

The appropriation for the 13th check is in the budget and our challenge will be to make sure it remains in the budget, hence the need for the continuous stream of emails.

the lobbyist and executive director of PERF, the public employee association. We decided that this would not be a good year to ask for more than a 13th check when many Hoosiers are out of work, worrying about rent and food, and having to school their children at home.

Meanwhile, we need to say that as we look at our oldest retirees, many of whom get less than \$1000 in monthly pensions, the 13th check is more help to them than a COLA of 1% might be over several years. I hope that you can understand the dichotomy that this poses for your Legislative team.

We won't know until the very end of the Legislative session whether our 13th check will be left in the coming biennial budget. Your emails will help make that possible so thank you for your support.

DID YOU KNOW?

Please Support the "13th Check with Modest Increase

•Retired teachers and public employees have received either a 13th check or COLA for 38 consecutive years.

•Nine years, from 1994 to 2002, they received both.

•The COLAs ranged from 1% to 9%.

•Approximately 9,000 retired teachers receive a monthly benefit of \$1000 or less. Approximately 3000 receive \$500 or less per month.

•Many retired teachers rely on the 13th check to help pay for living expenses such as medication or winter utility bills.

•To deny a 13th check after 38 consecutive years receiving an enhanced benefit would equate to a significant cut in benefits.

•Private sector jobs generally pay more than public sector jobs and therefore public sector pensions tend to be less. The lower monthly benefit amount justifies the allocation of the 13th check.

•HB 1227 which authorizes the 13th check with a \$50 increase, passed the Employment, Labor and Pensions Committee 11 - 0, the Ways & Means Committee 24 – 0 and 3rd reading by a vote of 92 - 1.

•Funding for the base 13th check for both years of the biennium is included in HB 1001. HB 1227 uses funds from the Supplemental Reserve Account to pay for the \$50 increase. The balance in the SRA is more than sufficient to pay for the increase this year and every year moving forward.

Retired teachers and public employees worked hard to earn a secure retirement. Please help them achieve that goal by supporting the 13th check.


